ENQUIRIES ABOUT RESULTS MADE EASY

Please note that any requests received after the deadlines **will not** be accepted.

Candidate consent

Candidates must provide written consent when submitting an Enquiry About Results (EAR). ***The school will not submit any requests where the consent box has not been filled in.***

REVIEW OF RESULTS (RoRs)

Clerical re-check (Option 1 on Form)

This is a re-check of all clerical procedures leading to the issue of a result.

This service will include the following checks:

- that all parts of the script have been marked;
- the totaling of marks;
- the recording of marks.

If you also want a copy of the re-checked script, select 1a. Some boards charge for this service.

Review of marking (Option 2 on Form)

This is a review of the original marking to ensure that the agreed mark scheme has been applied correctly. **It is not a re-marking of the candidate's script.**

This service will include:

- the clerical re-checks detailed above;
- a review of marking as described above.

If you also want a copy of the reviewed script, select 2a. Some boards charge for this service.

Priority review of marking (GCE only – Option 2P on form)

This is a priority review of the original marking to ensure that the agreed mark scheme has been applied correctly. **It is not a re-marking of the candidate's script.**

If you also want a copy of the reviewed script, select 2Pa. Some boards charge for this service.

This service is only available if a GCE A-Level candidate's place in higher education is dependent on the outcome.

Pearson/Edexcel also offer this service for GCSE.

Please note that for any of the above services, candidates' marks and subject grades may be lowered. Where there has been a reduction in marks or a downgrade, the request cannot be revoked and the original mark or grade cannot be re-instated.

ACCESS TO SCRIPTS (ATS)

Priority Access to Scripts (Option 3 on Form)

This service is available to candidates who are thinking of requesting a review of marking.

Return of original script (Non-Priority – Option 4 on Form)

Warning: once a candidate has requested a non-priority copy of a script (original script), they **cannot** request a review of marking.

Frequently asked questions

Which service do I want?

- a) I just want to see the script and do not want a review of the results:

You should request a copy of the script (No. 5 on the post-results services form).

- b) I want to see a script to decide whether to have its marking reviewed:

You should ask for a priority copy of the script (No. 4 on the post-results services form).

- c) A Higher Education place is at stake, what service shall I use?

You should apply for a priority review of marking (No. 3/3a). This is because you only have a very short window to request this service (August 24th 2023).

- d) If I request a copy of the script, can I use that to decide whether or not to have the marking reviewed?

Yes, provided that you request the priority script and submit the review of marking by no later than September 28th 2023.
